### Orientation program for CHC's

Two days Orientation was held at MPSSS, Bhopal (MP) on 5th and 6th December 2017 for the Community Health Coordinators under Community Health Project - Phase III. Participants were oriented on 'how to Enhance Collaboration with Government and Scale up services of community Health Intervention' in 6 Regional Units of CHAI from 2017 - 2020.

#### Objectives of Orientation:

- To Orient the MIs (Member Institutions) and Community Health Coordinators on Community Health Project Phase III
- To share and explain the project Base Line Data Collection tools
- To Facilitate CHCs to develop action plan for the next three months.



### Workshop on OD (Outcome Documentation)



All dioceses partners had raised concern over identifying outcomes, and ways of documenting them. As a result MPSSS had organized and called Fr. Jacob as the resource person for conducting training on Outcome based documentation on 14th December 2017. The objective of the workshop was to orient the participants on how to document the outcome of the respective project in which all are working. 10 participants who were part of the workshop include staffs from 9 dioceses and MPSSS staff.

### RRT Training (Regional Resource Team)

A one day RRT training was held on 15<sup>th</sup> December 2017 at MPSSS office in which 8 participants from 9 diocese participated. Regional Resource Team was conceptualized with an objective of creating pool of experts from all Dioceses. All the members came up with broader points /ideas for developing training modules, further as each one presented the ideas, topics were further discussed and made the topics specific to present / future needs of diocese and forum together is focusing on.



### PLD India Partners Meeting

PLD India partners review and planning meeting was held at Bhubaneswar, Orissa on 19th of December 2017. The objective of the meeting was to have sharing of outcome and impact of last three years activities.
